Wilbert Rideau

Wilbert Rideau spent 44 years in the Louisiana prison system, first on death row and later as a life-sentenced prisoner before a retrial in 2005 freed him. For 25 years, Wilbert was the editor of *The Angolite*, the nation's only uncensored prison publication; he won many of journalism's top national awards for his exposés of prison life. While behind bars, he also helped produce award winning radio, television, and film documentaries about prison. His memoir, *In the Place of Justice: A Story of Punishment and Deliverance*, was recently published by Alfred Knopf; he will be signing copies at the event. He is a consultant with the Federal Death Penalty Counsel Project working to help capital attorneys better understand their clients and counseling capital defendants on their concerns or fears that may negatively affect defense efforts.
